Dear Friends,

In 2024, the affordability crisis facing the Greater New York region reached a tipping point. As rents continued to rise, data revealed that a quarter of New Yorkers struggle to afford the essentials. We also learned that more than 30% of adults with a mental health diagnosis aren't getting the care they need. Our communities urgently need more affordable housing and mental health support.

As you'll read in these pages, VOA-GNY is rising to meet the moment. Construction on our newest development, YP Senior Residence, is now complete and 117 low-income and formerly homeless seniors in need of an affordable place to call home are moving in. Building on this success, VOA-GNY was selected as a co-developer of a transformative project on Staten Island that will produce 235 new units of affordable housing over the next five years.

Our team is also focused on innovative and sensible solutions to help our neighbors living in public spaces, many of whom have unmet health needs. Over the past two years, 20% of all unsheltered New Yorkers who transitioned to permanent supportive housing were placed through our Street to Home pilot program. The unprecedented success of this pilot continues to attract attention from policymakers who share our goal of bringing this work to scale.

Each time we see data emphasizing the magnitude of the housing and homelessness crisis, we remind ourselves that every unique data point represents the story of a person persevering through extraordinary hardship. In these pages, we are proud to share the impact you helped us make in 2024, alongside our clients' stories of hope and resilience. We hope you—donors, corporate and nonprofit partners, policymakers, and our staff—recognize that you are a vital part of these stories.

On behalf of the board, we thank you for your unwavering support. Without you, this work would not be possible.

Volunteers of America-Greater New York (VOA-GNY) is an anti-poverty organization with a 129-year history of serving individuals and families in need.

WHAT WE DO

With more than 70 programs across New York City, Northern New Jersey and Westchester County, VOA-GNY addresses the urgent needs of people who are experiencing or at risk of homelessness, while developing innovative program models and advocating for public policy reforms that lead to large-scale change.



Housing

As a nonprofit housing developer and trusted human services provider, VOA-GNY helps individuals and families move out of homelessness by offering a continuum of temporary, transitional, and permanent affordable housing with wrap-around support services.



Health

After meeting their housing needs, we help clients focus on their next step by connecting them to physical and mental health services. Our case managers and social workers utilize proven interventions to address mental health needs and link clients to community resources.



Wealth-Building

Wealth is a crucial component of long-term resilience, serving as a cushion when income streams are disrupted. VOA-GNY's economic empowerment programs, including workforce development, financial literacy, and continuing education, support clients seeking to strengthen their career opportunities and set out on their journey to build wealth.



Public Policy

VOA-GNY tirelessly advocates for our clients by educating the public about the root causes of homelessness and proposing public policy that is informed by data and experience. We draw upon the expansive expertise of our team as well as the lived experience of our clients to fight for legislation and funding that can create transformational change.

SHANIQUA

After a long day, Shaniqua and her 16-year-old son, Zion, enjoy playing video games together while living at VOA-GNY's University Family Residence, a transitional shelter for families experiencing homelessness. They're rebuilding their relationship after 10 years of separation.

"I try to have 'us' time because we need that," she says.

Born and raised in the Bronx, Shaniqua, a mother of four, has had a challenging journey. A survivor of child abuse and domestic violence, she struggled with substance use which led to having her children removed from her care. Determined to reunite her family, she spent two years completing parenting classes and a substance use program, eventually regaining custody of her youngest child, Zion.

Since arriving at VOA-GNY with Zion a year ago, Shaniqua has made significant strides. With guidance from VOA-GNY staff, she completed a parent leadership training program that led to a job as a parent advocate at a human services agency. She assists families who are trying to reunite with their children, just like she did.

"I was once them," she says. "I had to fight to get my child back and I don't want them to have to go through what I had to go through."

Shaniqua has leaned on VOA-GNY staff through difficult moments.

"If I need to talk to somebody, Ms. Ndela is definitely there for me to go and talk to," she says about her case manager. "She's just real supportive."

Shaniqua is in the process of securing an apartment—a permanent home for her and Zion where her oldest kids can come visit too.

"I try to have 'us' time because we need that."

Public policy is integral to advancing our vision. This year, we engaged every level of government, providing testimony before five City Council committees, lobbying for critical funding, and successfully influencing key legislative outcomes.

Staff attended the National Women's Shelter Network conference in Washington, DC and met with congressional leaders to discuss the need for federal investment in shelter services for women and families.

VOA-GNY joined the Housing and Community
Development Network of New Jersey in Trenton, NJ to
lobby for funding for affordable housing and bills that
would help more people in the state access housing.

YOUSEF*

After sleeping on city benches and trains for years, 37-year-old Yousef* finally feels safe now that he has a room of his own at Eden House, one of VOA-GNY's permanent supportive housing programs. He was offered the room through Street to Home, our Housing First pilot that moves people experiencing unsheltered homelessness directly into housing.

"I finally feel relaxed, secure," he says. "I don't always have to worry and watch my back all the time."

Born and raised in Brooklyn, Yousef lived with his large, tight-knit family, until a death in the family broke them apart. Yousef's father became incarcerated, and his mother lost her job. Yousef was sent to live with his uncle, where he was exposed to gang involvement and drugs. Without a positive role model, he dropped out of high school.

"I lived and I learned from all my mistakes," he says. "I still make some mistakes."

Despite working restaurant and delivery jobs, Yousef struggled to find stable and affordable housing, leading him to live on the streets. In April 2023, an outreach team approached Yousef about Street to Home while he waited in line at a church soup kitchen.

Since moving to Eden House, VOA-GNY staff have helped Yousef access medical care. He also worked with a vocational counselor to find employment and participates in financial literacy support groups to continue his wealth-building journey. He hopes to learn a new trade and eventually have children.

"For my future, I would like a family," he says. "But raise them better than how I was raised."

LENORE

Sixty-one-year-old Lenore is reconnecting with her hobbies after living in New York City shelters for years. She enjoys writing poetry and staying active with fitness classes like Tai Chi and Zumba. She's found stability at VOA-GNY's East 12th Street Residence, a permanent supportive housing program for older adults, many of whom have experienced homelessness.

"I've been in the shelter system too long," she says. "I came here, and I loved it."

Born in New York, Lenore moved to Pennsylvania at the age of 8 where she lived until a few years ago. She was evicted from her condemned apartment and came back to the city. Throughout the years, Lenore has struggled with managing her mental health diagnoses and has lost contact with her family. She lived in five shelters before securing permanent housing.

"I learned I'm resilient," Lenore says. "No matter how many times I go down, I just keep getting back up."

Now that she has a stable place to live, Lenore has taken a proactive approach to her overall health. VOA-GNY staff are supportive and able to connect her to resources in the community. With guidance from her case manager, she's received consistent counseling and established care with a nearby doctor.

"Coming from the shelter all the way to just living independently, she's doing much better for herself," Imelda Escarfuller, the program's senior case manager, says.

Lenore enjoys cooking and is an active participant at the senior center in the same building.

"I'm grateful for a chance, for a place like this," she says. "I am very grateful to VOA."

With construction now complete, 117 low-income and formerly homeless seniors will soon be able to call YP Senior Residence home—named in honor of the **YP Foundation**'s generosity to VOA-GNY. Modeled after our East Clarke Place Senior Residence, this is our second ground-up development for older adults in the Bronx that takes an innovative approach to combating social isolation through architectural design and on-site support services.



In the next 5 years, VOA-GNY's pipeline of projects will leverage an anticipated

VOA-GNY was selected as co-developer for **Hillside Grove**, a transformative community development project near the North Shore of Staten Island that will advance housing, food, and environmental justice on one campus. The project will replace an unpopular sanitation depot and add a grocery store to the neighborhood, which has been identified as a food desert.

found refuge in one of our domestic violence shelters Eight years ago, Shelley found safety and healing at one of our confidentially-located domestic violence shelters. This year, she bravely shared her story at our second annual domestic violence symposium.

Growing up, she had to endure the sounds of her mother being abused behind a closed door. It's an experience she was determined not to repeat as an adult. While living in Florida with her son, Shelley was elated to have met a partner who treated her well—until the physical abuse started and she made the difficult decision to leave.

When she entered our shelter in NYC, Shelley felt ashamed, tired, angry and defeated. "I couldn't believe that this was my life again," she said. It took her months to open up, but VOA-GNY staff never wavered in their support and instead met Shelley where she was at. "The staff was always willing to help," she said, "whether it was housing assistance, childcare, encouragement, or simply a hug." Before leaving the shelter, she secured a job at a law firm and, today, is giving back by helping other survivors.

"I'm immensely fortunate to have had [VOA-GNY] as my support team and to have them as part of my story." Sand tray therapy and other clinical art interventions were a focus of this year's symposium, which explored the impact of domestic violence on children and youth including pediatric brain injury.

Neurosurgeon **Dr. Edie Zusman** of Safe Living Space and Associate Professor **Kathleen Monahan** from SUNY at Stony Brook returned as guest speakers.




